

TERMS AND CONDITIONS - WIN PROMOTION – PORT LINCOLN HOTEL

1. The Promoter is: Port Lincoln Hotel (ABN 57 519 972 982) of 1 Lincoln Highway, Port Lincoln SA 5606. The above mentioned company will be hereafter referred to as the 'Promoter.'
2. Employees of the Promoter or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition.
3. To enter the competition an entrant must purchase an accommodation package via the hotel website [www.portlincolnhotel.com.au](http://www.portlincolnhotel.com.au) using the promotion code: WIN
4. Closing date for entry will be 12 Midnight (AEDT) Wednesday 20<sup>th</sup> September 2023. After this date no further entries to the competition will be permitted.
5. Win promotion is valid for bookings made between 17<sup>th</sup> August 2023 and 20<sup>th</sup> September 2023 for stay dates between 1<sup>st</sup> September 2023 and 22<sup>nd</sup> December 2023. Blackout dates 30 Sept – 14 Oct inclusive.
